4 FIRST AID MEASURES

4.1 Description of first aid measures:

In case of respiratory exposure: Remove to fresh air and keep at rest. If breathing is difficult or has stopped, administer artificial respiration as necessary. Seek medical attention.

In case of skin contamination: Wash contaminated area thoroughly with soap and water. Remove and wash contaminated clothing. If a persistent rash or irritation occurs, seek medical attention.

In case of intrusion into eye: Immediately flush eyes with large amounts of running water for at least 15 minutes, lifting the upper and lower eyelids. Get medical attention.
